Professional investors have purchased rent-regulated and subsidized multifamily housing in New York City since 2001. This has heightened expectations for financial performance, intensifying displacement pressure through increasing rents, harassment, eviction, and when financial targets are not met, foreclosure and physical deterioration of buildings. This investment contrasts with the previous generation of the local, independent "tenement landlord"—who strategically under-maintained buildings to realize modest returns over decades of ownership. The transformation in ownership and management of rent-regulated housing is a function of the integration of real estate and financial markets, the role of the state in supporting new sources of rent, and previous waves of property reinvestment. These processes reconfigure the real estate investment and state power at the "urban frontier," presenting new challenges and opportunities for political struggle.
